**SUBJECT: Mid-month Post adjustment classification memo for September 2019**

1. I am pleased to send you the post adjustment multipliers for September 2019. Note that only duty stations with changes in post adjustment multipliers as compared to the previous memo ICSCPADJ-0919-01 are listed.

**Group I Duty Stations**

2. The post adjustment multipliers, applicable to group I duty stations, as a result of the operation of the 0.5 per cent rule under conditions of currency depreciation/appreciation relative to the US dollar, with effect from 1 September 2019, are given in Table 1.
